Nichols – As of December 8th: Revenue 103.7%, Administrative expenses are at 89.7%, Operations 91.1%, Capital at 50.9%, for a total expenditure at 85.2%. We are in good shape.

New Business

Budget Final Reading. Chief Mercer presented all three budgets for final adoption. 2022 year to date numbers have been brought to current. Moved subscriptions all under 1 line item, reduced vehicle maintenance. Webber made a motion to approve the 2023 Fire Department Budget as presented with total revenues \$1,080,562.00 expenditures \$725,572.00, net revenue over expenditures \$354,990. Kowach seconded. Motion passed (3:0) HazMat has been updated to reflect current year to date. Increased physicals to reflect a rotating physical schedule for HM Techs. Kowach made a motion to approve the 2023 Moffat County HazMat budget as presented with total revenue \$42,000.00, total expenditures \$17,250.00, and net revenue over expenditures \$24,750. Webber seconded. Motion passed. (3:0) Pension has been updated to better reflect funds used from Pension Account. In years past this has been under unrealized gains/loss, however those are hard to predict for budget purposes. Kowach made a motion to approve the 2023 Pension Budget as presented with total revenue \$263,660.00 expenditures \$263,660.00, net revenue over expenditures \$0.00. Webber seconded. Motion passed. Was a real nice event. Also attended the Holiday drive with toy donations, fire inspections and fire extinguisher classes.
