Chief Mercer – We had 30 calls in April. 21 Fire, 9 EMS, and 0 HazMat. Rookie academy is ongoing. PR has been busy with station tours, safety days and children's festival. Have received part numbers and pricing on some parts outstanding for fleet. The pump seal for E7 is here. We had a tire blow out on T2, it has been replaced, we need to replace the rest. Current tires are from 2005. Ordered locks for Bays, will install. Lobby lights have been installed. The Luau is June 3rd. New shirts are here. Expecting flood high water day tomorrow, mostly along Elk Head Creek and Yampa River. Thinking about rescues. Looking into a support rookie program, looking at options for a limited level, having an asset on the ground, but not in the fire. Creating a policy, based on the cadet policy, looking into feasibility. Will present policy next month.
