# Budget Review

Nichols – Revenue 1.9%, Administrative expenses are at 7.3%, Operations 6.2%, Capital at 5.9%, for a total expenditure at 6.9%. Some bills are still coming in. We will move some of leftover into capital, approximately \$100,000. We're in decent shape.

#### **New Business**

Chief Mercer – Would like to look into the idea of a snow plow on a 4-wheeler to plow station/sidewalks. Bringing up the idea to see if this needed it to be a consideration for the 2023 budget. Webber supports the idea, Questions regarding insuring it, registering it, maintaining it. Nichols asked for a firm price.

# Reports from the Chief -

Chief Mercer – We had 40 calls in January. 20 EMS, 17 Fire and 3 HazMat. Rookie academy is in process, and will be starting HazMat soon. We have promoted Lt Hampton to Captain, and are interviewing for Lieutenant this week. Fleet is in good shape. There is a heater control valve in E1 that is bad. We are working on replacing it. R1 had a recall on the fuel rail. It has been completed. DEF tank sensors are on order to complete the recall. L1 parts are still at Max Fire. We are still waiting on a bid from H&E; Captain Olsen is working on that. T1 is leaking power steering fluid from a fitting. Going to add additional lighting to command vehicle. Steamboat Fire is looking into building a training facility. A training officer and a board member came over to look at ours. In discussion, they are putting on an academy in April and May and would like to come use our facility for training. Door combos have not been changed, looking at changing the locks themselves. Parts are difficult to source, and locks themselves are \$800 each. New digital locks are about same size, have 10-digit key pad and take less time to recode than the current ones. Can replace all locks for about \$800. Policy revisions, our policies are very outdated, most have not been revised since 2013. There are other companies that offer policies.

The P.D. and S.O. use a company called Lexipol. Had a demo at the last officers meeting. They offer 165 base policies to choose from, as well as custom revision to specific policies It is an annual subscription that has a minimum 1-year agreement. They estimate it to take a year and a half to two years to update entire policy manual. They also offer additional trainings, tracking and record keeping. Forgay asked about a work group to review policies. Webber asked if it would be better to outsource so officers could make better use of their time. Nichols thinks there is too many "us specific" policies, and that we would not be a good use of our time. Forgay suggested that it would be cheaper than a lawyer.
