Nichols – Revenue 69.3%, Administrative expenses are at 36.9%, Operations 25.3%, Capital at 9.5%, for a total expenditure at 30.8%. We have not funded Pension yet.

#### **New Business**

ADM-42 – Working with some staffing issues, looking into bringing some people on board through a support rookie program. Provide them with some training and then roll them into the academy at the first of the year. Present a policy that outlines the support rookie program. Hume – could use some formatting, maybe add some definitions. Willing to help. Nichols had questions regarding the participation piece. Perhaps we should table it while we get some changes in place. Hume suggests we work on it and bring it back next month. Nichols made a motion to table ADM-42. Chapman seconded. Motion passed. (5:0)

Audit – Nichols reviewed the audit. Pension has dropped from 115% funded to 98% from the hit we took last year. There was no instances of non-compliance or fraud. It was a clean audit. Hume made a motion to accept the audit. Nichols seconded. Motion passed. (5:0) Tonya told the Board that Greg, the Auditor was retiring, and that we would need to begin the search for a new Auditor.

Chief Mercer – We had 22 calls in May. 14 Fire, 8 EMS, and 0 HazMat. Fire 1 practical and live fire practical are done. 1 rookie is out with an upcoming back surgery. Will be working on his classes through zoom, and try to get through the written tests. PR has been busy with school safety days, tours, and luau. Fleet – E1 & R1 parts ordered through Ikon. E7 pump is repaired. The twins are having some charging problems. Wildland season is starting soon. Door locks are here, programed and being installed. The roof repair is in the queue for

the engineer. Reaching back out. Luau had \$3040 in sales. Hose testing is Saturday at 7:00 am. 4<sup>th</sup> of July invites are out. Checking to be sure it's ok to start with larger capital purchases. Nichols – approved budgeted items are ok. Chief Mercer read Firefighter Bohrer's letter of retirement to draw Pension, and continue to serve. Hume made a motion to accept Bohrer's retirement and reinstatement per board resolution and Colorado State statute. Chapman seconded. Motion passed. (5:0)
